ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, KN Bakshi College of Education, Plot No.460/1 & 441/549, Vill.-Karmatand, Po. – Bengabad, Tehsil/Taluka – Bengabad, Town/City – Giridih, Dist. – Giridih, Jharkhand – 815312 had submitted an application (Code No.ERCAPP1270) to the Eastern Regional Committee of NCTE for grant of recognition for conducting B.Ed Course with an annual intake of 100 (one hundred) by online on (mm/dd/yyyy) 9/30/2011 and hard copy of application submitted on (mm/dd/yyyy) 10/7/2011.

2. WHEREAS, as per the decision of ERC in its 154 meeting held on 22-23 April 2013, recognition order was issued to KN Bakshi College of Education, Plot No.460/1 & 441/549, Vill.-Karmatand, Po. – Bengabad, Tehsil/Taluka – Bengabad, Town/City – Giridih, Dist. – Giridih, Jharkhand – 815312 for conducting B.Ed. Course of Secondary (level) of one year duration with an annual intake of 100 (one hundred) from the academic session 2014-2015 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009, vide ERC order No. ERC/7-154.6.21/NCTE/B.Ed./2013/17971 dated 04-May-13.

3. AND WHEREAS the applicant institution/trust/society filed a writ petition (C) No. 409/13 in the Hon'ble Supreme Court of India against the said recognition order dated 04-May-13 issued by ERC, NCTE and the Hon'ble Supreme Court disposed of the writ petition with a direction that recognition granted by the NCTE to the institution will apply for the academic session 2013-2014.

4. AND WHEREAS the Eastern Regional Committee in its 159 Meeting held on 06-Aug-13 considered the original file of the institution along with the order of the Hon'ble Supreme Court dated 03-Jul-13 and decided that revised recognition order from the session 2013-2014 may be issued to the institution instead of the session 2014-2015.

5. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to KN Bakshi College of Education, Plot No.460/1 & 441/549, Vill.-Karmatand, Po. – Bengabad, Tehsil/Taluka – Bengabad, Town/City – Giridih, Dist. – Giridih, Jharkhand – 815312 for conducting B.Ed. Course of Secondary (level) of one year duration with an annual intake of 100 (one hundred) from the academic session 2013-2014 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009.

6. The recognition is subject to fulfillment of the following:
- (i) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - (ii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
 - (iii) The institution shall ensure that the required number of academic staff for conducting the course is always in position.
 - (iv) All such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.
 - (v) The institution shall submit the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
 - (vi) The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
 - a. Copy of the Application Form
 - b. Land and Building Particulars.
 - c. Staff Profile
 - d. Recognition letter
 - e. Information for having fulfilled the norms & standard and other required conditions.

7. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.



ORDER


WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. **AND WHEREAS**, the institution viz. **KN Bakshi College of Education, Plot No.460/1 & 441/549, Vill.-Karmatand, Po. – Bengabad, Tehsil/Taluka – Bengabad, Town/City – Giridih, Dist. – Giridih, Jharkhand – 815312** was granted recognition as per Regulations 2009 for conduct of B.Ed. course of **One year** duration with an annual intake of **100 (one hundred)** from the academic session **2013-2014** vide ERC order No.ERC/7-159.2(ii).1/2013/20199, dated **14.08.2013**.

3. **AND WHEREAS**, the institution viz. **KN Bakshi College of Education, Plot No.460/1 & 441/549, Vill.-Karmatand, Po. – Bengabad, Tehsil/Taluka – Bengabad, Town/City – Giridih, Dist. – Giridih, Jharkhand – 815312** has by affidavit dated **22.01.2015** consented to come under New Regulations 2014 and sought for **two basic units in B.Ed course**, which require additional facilities.

4. **AND WHEREAS**, it has been decided to permit the institution to have two basic units of 50 students each subject to fulfill following conditions namely,

- (i) The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committee with required documents by October 31, 2015.
- (ii) The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.

(iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.


5. **Now therefore**, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Eastern Regional Committee, NCTE hereby grants recognition to **KN Bakshi College of Education, Plot No.460/1 & 441/549, Vill.-Karmatand, Po. - Bengabad, Tehsil/Taluka - Bengabad, Town/City - Giridih, Dist. - Giridih, Jharkhand - 815312** for conducting **B.Ed Programme of two years** duration with an annual intake of **100 (one hundred)** for **two basic units of 50 students each** from the academic session **2015-2016** subject to fulfillment of the conditions mentioned herein before 31.10.2015.

6. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.

7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution:
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter:
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.:
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. If it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.



If the institution Contravenes any of the above conditions of the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17 (1) of the NCTE Act.
