

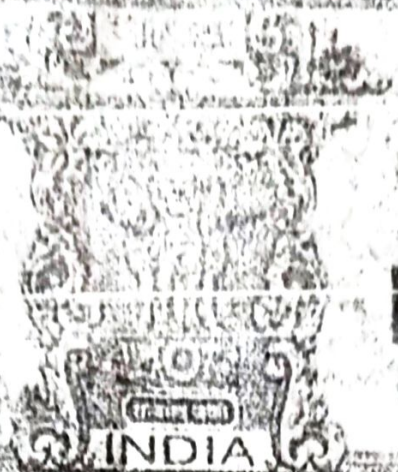

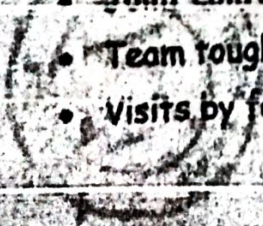

1. Objective of MOU:

To organize co-curricular sessions and activities for improved learning outcomes and lifeskills of the students of KNBCE and organize regular sessions for the same as a part of the School for Life program of Abhivyakti Foundation which ensures to bring self and social awareness among the students. AVF is collaborating with KNBCE as an collaborating partner in the School for Life, where students are selected and trained over various life-skills and social realization to contribute to the nation building.

2. Obligations:

Both the organizations acknowledge the fact that no contractual relationship has been created out of this MOU and they agree to work in unison towards their respective goals and targets to make this collaboration a success and thereby exemplify the spirit of transparency and responsibility.

3. Cooperation in view of this Collaboration:


The MOU shall oversee the functioning of KNBCE & AVF as collaborative partners to the School for Life initiative.


The roles for both the parties would be:

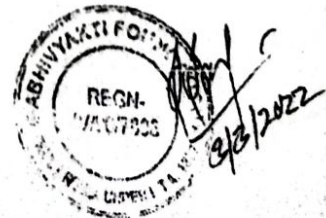
A. Role of AVF:

1. Representatives of AVF will join a webinar to represent the course overview to encourage students to join as a trainee/course learner.
2. For each of the course AVF shall nominate a Course Coordinator and intimate to KNBCE point person for regular follow up and course arrangements.
3. The identified students will be trained by qualified resource persons / trainers from AVF based on the subject and schedule finalized in consultation with KNBCE.

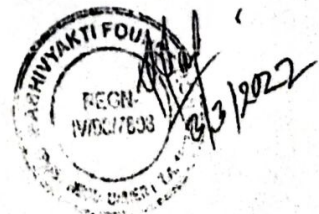
4. AVF will design and share course module and handouts before the start of the training in soft copies to KNBCE for distribution among students.
5. AVF & KNBCE will ensure all the policies related to prevention of Sexual Harassment or Discrimination which is applicable to their employees or is applicable as per the Law of the Land will be applicable to the students, staff, vendors, and volunteers involved in this program.
6. AVF will encourage sessions with hands-on and activity-based learning for which students will be encouraged to do some home assignments as well.
7. Student participation shall be shared by AVF in the form of credits (A tracking mechanism used to see how the student has performed their role through the course) to KNBCE as per forms prescribed by KNBCE, to help grade the students as a part of their course.
8. AVF will provide at least one mentor on every 5 students/ interns.
9. The above said courses would be designed for 1 to 2 credit each. The initial understanding is to launch 3 to 4 courses in an academic year which can be further revised after mutual consultation and agreement of parties. A calendar will be prepared at the start of the academic session, however, the exact dates of the duration would be announced time to time on mutual consent of parties.
10. AVF shall provide the 'Certificate of Completion of the Training Course, within a month of the completion of the internship.

B. Role of KNBCE:

1. Ensuring to provide a platform for students to be addressed about the upcoming courses before launch of such short duration training courses.
2. Encourage students to join AVF and give them permission to attend events and classes as per the schedule mutually agreed.
3. Provide uninterrupted power back up for sessions especially during the time of presentations using digital equipment.
4. Print and provide print copies of handouts, course materials and pre-post training evaluation forms shared by in soft copies by AVF to each of the students.

5. Ensure attendance of students in the sessions and in case of any interruptions or change in schedule due to highly compelling reasons, will intimate at-least a week in advance to reschedule the sessions.
6. KNBCE shall provide platforms for AVF to organize various sensitization activities for students of KNBCE.

4. **Financials:**

AVF & KNBCE will be responsible for their own costs and expenses involved in their efforts to negotiate, conclude and fulfill their obligations under this MOU. Notwithstanding anything to the contrary contained herein, both the parties shall render entire their services under this MOU on pro bono basis i.e. without charging or seeking reimbursement of any payment, fee, charges whatsoever mutually.

5. **Use of Logo/Name**

"Permission is given to both the parties to use the official marks of the other party specifically the institutional name and/or institutional logo solely for the purposes of promoting and administering the collaborative activities between the institutions; Provided, that the party using the official marks of the other party shall take all such reasonable degree of care as an institution of good ethical and normal prudence would expect in its own case."

6. **Arbitration and Jurisdiction:**

In case of any dispute arising between the parties in respect to any of the terms in this MOU, the parties undertake to settle the same by issuing a notice within 15 days from the date of the issue becoming known to either party. In case no such settlement is arrived at after mutual negotiations, the matter may be resolved by arbitration and shall be governed by the provisions of the Arbitration and Conciliation Act 1996 subject to any statutory modification, amendment or re-enactment, from time to time.

8. **Term of MOU:**

This MoU, unless extended by mutual written agreement of the parties, shall expire 5 years after the effective date specified hereinabove. This MoU may be amended or terminated earlier by mutual written understanding of the parties at any time. 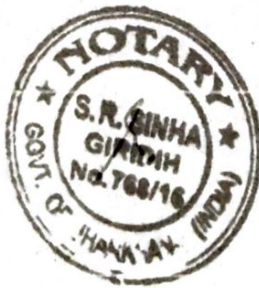
